Tuition + Technology + Camps + E-Texts + Excursions

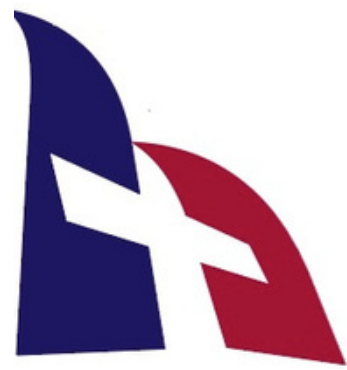

# School Fees 2023

School fees are billed annually through FACTS. FACTS provides families with control and flexibility to establish an automated payment plan that suits them. Accounts paid in full prior to 31 January 2023 will attract a 5% discount on the tuition fee component.

## What is included?

- Tuition fees
- Compulsory activity fees
- Camp fees
- Secondary elective fees
- ICT levy
- Building and library levies

## Tax deductible donations

Hunter Christian School has established tax-deductible Building, Library and Scholarship funds. Donations can be made any time during the year. For more information, please contact the school office.

## VET courses and online learning

VET courses will incur an additional materials and equipment levy of \$500 per course. Students undertaking a VET course offered by an external provider will be charged the course fee less a HCS subsidy of up to \$1,000 per student and any government EVET subsidy. Students undertaking online learning courses will be charged the course fee less a HCS subsidy of up to \$500 per student.

## Financial Assistance

The school has a limited budget to assist families experiencing genuine financial hardship. Financial assistance is applied to the tuition component of school fees and is granted conditionally on the student remaining enrolled for the whole of the school year after commencement. Refunds for camps and excursions will be considered on a case-by-case basis and only in circumstances where a refund is available to the school from the external provider.

## Notice of Withdrawal

If a parent wishes to withdraw a student from the school, notice given must not be less than 10 school weeks or one full school term. If the required notice is not given, full fees will be payable in lieu.
